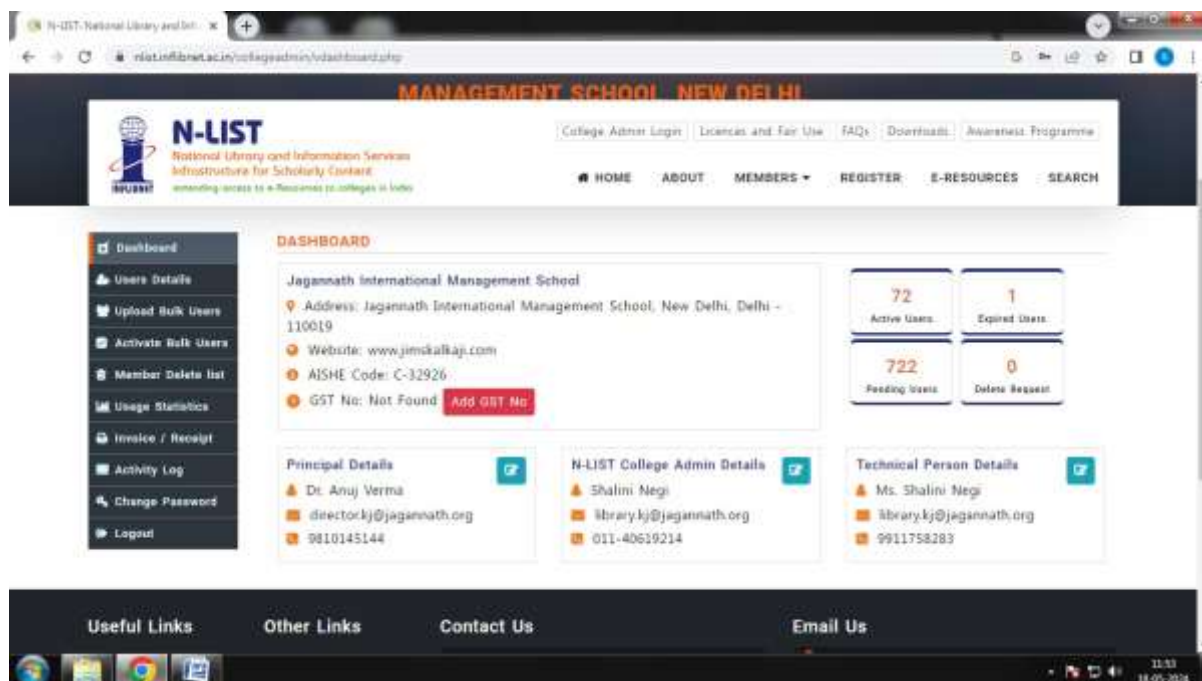

ABSTRACT
The institutional and organisational fabric of the global asset management industry is the focus of this paper. Using a stylised version of four models of management evident in the global asset management industry, it is argued that rather than sharing tacit knowledge within and between investment managers hoarding and rent-seeking dominate the industry. It is also suggested that geography matters: realising value in the investment management industry is mediated by institutional frameworks, regulatory-settings, and the incentives driving those who may claim rents on their 'magic sauce'. The reach and significance of these propositions are illustrated by reference to the Canadian banking and clients and their peers in New York and Toronto.

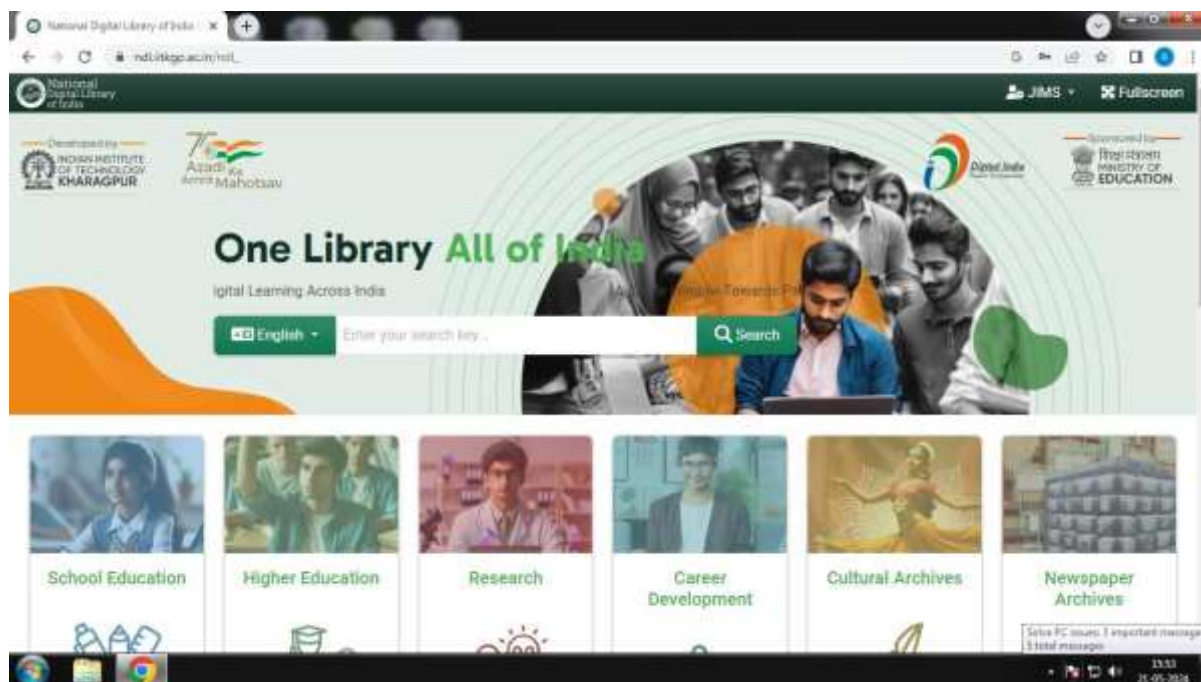


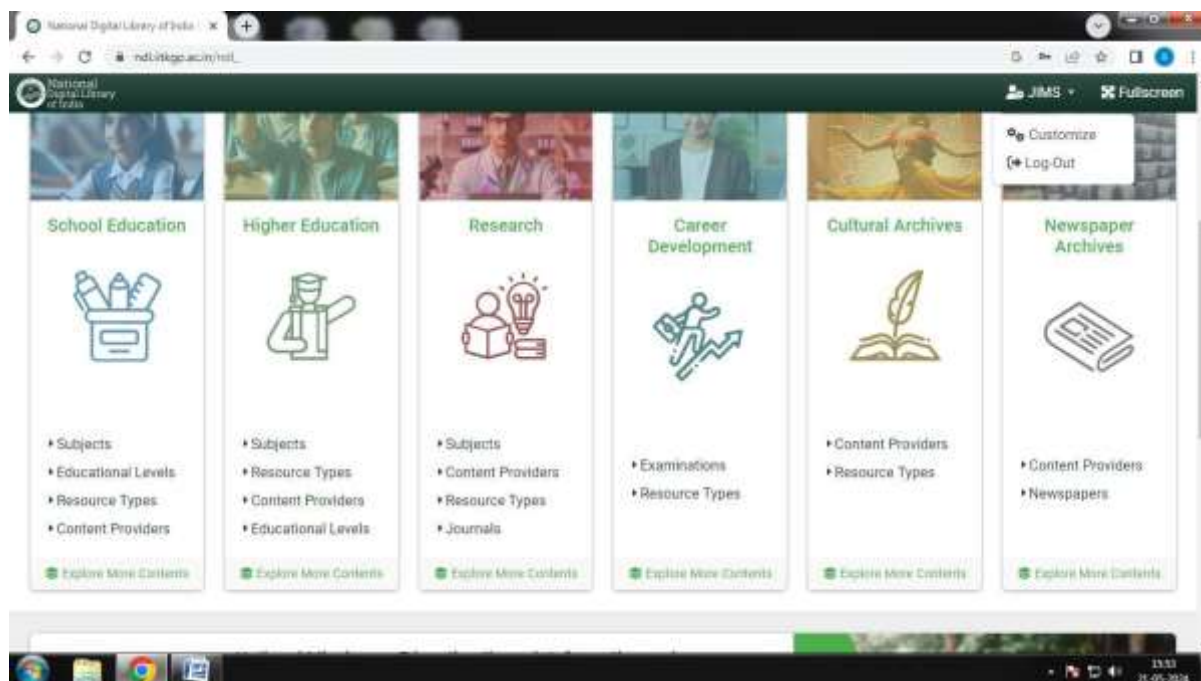

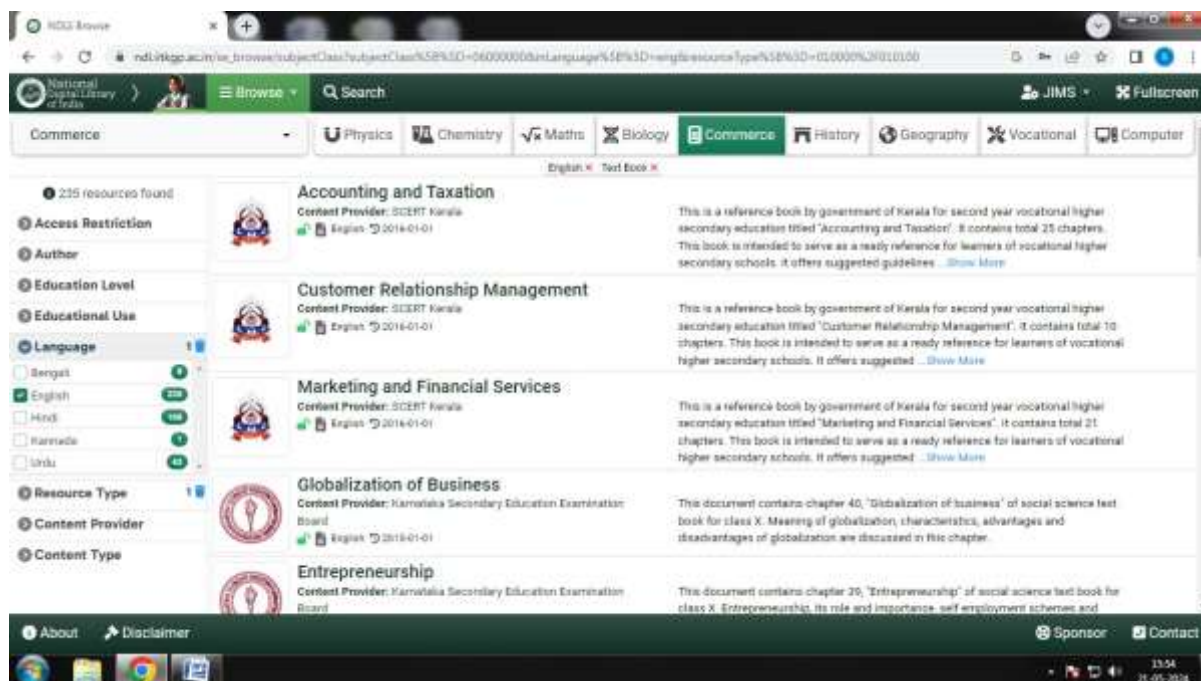
