• To ensure effective solution to the student's grievances with an impartial and fair approach.


### **Functions of Grievance Redressal Committee**

- In case the person is unwilling to appear in self, grievances may be dropped in writing at the letterbox/ suggestion box of the Grievance Cell at the reception. Grievances may also be sent through e-mail to the faculty representatives at pallavi.ahuja@jagannath.org or dolly.sharma@jagannath.org.
- The cases will be attended promptly on receipt of written grievances from the students. The Grievance Cell will act upon those cases which have been forwarded along with the necessary documents.
- The Grievance Cell will assure that the grievance has been properly solved in a stipulated time limit provided by the cell
- The cell formally will review all cases and will prepare statistical reports about the number of cases received. The cell will give report to the authority about the cases attended to and the number of pending cases, if any, which require direction and guidance from the higher authorities.



## Grievance Redressal Committee

## Procedure For Seeking Redressal of Complaint

Jan 06, 2024

- The aggrieved student or person seeking redressal of grievance may submit an application to the committee secretary
- 2. On receipt of an application the committee secretary shall inform the Committee Chairman and shall immediately provide a copy to the Chairman for furnishing its reply within seven days.
- 3. The Committee Chairman shall fix a date for hearing the complaint which shall be communicated to the Institute and the aggrieved person either in writing or electronically, as may be feasible.
- An aggrieved person may appear either in person or represented by such person as may be authorized to present his case.
- The Committee Chairman shall be guided by principles of natural justice whilst hearing the grievance.
- The Committee Chairman shall ensure disposal of every application within one month of receipt for speedy redressal of grievance.
- The Institute's staff shall be expected to co-operate with the Committee Chairman in redressal of
  grievances and failure to do so may be reported by the Committee Chairman.
- 8. On the conclusion of proceedings, the Committee Chairman shall pass such order, with reasons for such order, as may be deemed fit to redress the grievance and provide such relief as may be desirable to the affected party at issue.
- 9. Every order under clause (8), under the signature of the Committee Chairman shall be provided to the aggrieved person and the university and shall be placed on the website of Institute.
- 10. The Institute shall comply with the order of the Committee Chairman.
- 11. A complaint shall be filed by the aggrieved student, his/her parent or with a special permission from the Committee Chairman, by any other person.






