Whereas,

DELIVERABLES

- Arrangement of 3kg laddoo in exchange of INR 750 by Party 2.
- 1 Appreciation letter in name of Dr. Preeti
- 1 Reel will be made by us & posted in collaboration with Party 2 wherein both the organization's logo shall be featured prominently.
- Social Media Promotion.

As per collaboration, **Party 2 - NSS, JIMS** will provide:

- Transfer of INR 750 to Party 1, for arrangement of 3kg Laddoos.
- Arrangement of 60 Packets of Refreshments, containing Samosa & Beverage along with disposables plates.
- Arrangement of Gulaal Colors & Water Balloons etc for Holi Celebration.
- All the expenses for the same shall be incurred by Party 2, if any packets left, it shall be donated to Party 1 for further distributions.
